## Assistant/Associate Professor, Tenure-track Early Childhood Mathematics Education Faculty Member

**Setting:** Kent State University (<a href="http://www.kent.edu/">http://www.kent.edu/</a>) is located in Northeast Ohio, a geographic area rich in institutional diversity. Kent, Ohio (<a href="http://kentohio.org/">http://kentohio.org/</a>) is a mid-sized community on the Cuyahoga River, approximately 10 miles from Akron and 35 miles from Cleveland. With an enrollment of more than 42,000 students in undergraduate, graduate and off-campus programs, the university is ranked among the nation's 77 public research universities demonstrating high-research activity by the Carnegie Foundation for the Advancement of Teaching. In 2013, the *Chronicle of Higher Education* honored Kent State in its list of "Great Colleges to Work For." Additionally, the undergraduate early childhood program has a conceptual framework centered in social justice and equity and is the first teacher education program in the world to offer teaching credentials for Primary Years International Baccalaureate.

**Description:** The successful applicant will:

- develop/maintain an active research program in mathematics education;
- teach early childhood undergraduate, master's and doctoral courses in mathematics education;
- seek extramural funding;
- recruit and advise graduate students in mathematics education;
- actively participate in program, school, college and university initiatives and committees; and
- provide leadership for state, national, and/or international math education organizations.

**Qualifications**: Minimum qualifications include an earned doctorate in mathematics education or closely related field by August 2015; active research agenda (preferably at the preK-8 level); a minimum of three (3) years of mathematics teaching experience at the pre-college level (preferably at the preK-8 level); equivalent of an undergraduate degree in mathematics; and demonstrated knowledge of early childhood development.

**Salary:** Competitive and commensurate with qualifications.
