AMTE PRESIDENT'S MESSAGE

AMTE Looks Forward to a Year of Celebrating the Past, Participating in the Present, and Preparing for the Future

I am very excited to become the new AMTE President. This is an exciting time for AMTE as we celebrate two decades of service to the profession, and as we face the challenges related to mathematics teacher education in the coming year. With our fifteenth annual meeting, AMTE started off the new year in great style, with 579 members in attendance, including 104 graduate students, and 146 sessions. Each of the keynote speakers, Marilyn Burns, Joan Ferrini-Mundy, and William F. Tate, IV left members thinking about the work of teacher educators and the challenges we face. Other highlights from the meeting included the announcement of the AMTE 2011 awards to Rochelle Gutiérrez of the University of Illinois, who received the *Excellence in Mathematics Teacher Education Award*, focusing this year on excellence in scholarship, and Kathryn Chval of the University of Missouri, the recipient of AMTE's *Early Career Award*.

Also, AMTE's seventh monograph, *Mathematics Teaching: Putting Research into Practice at All Levels*, edited by Johnny Lott (University of Mississippi) and Jennifer Luebeck (Montana State University) was presented to members. The monograph highlights examples of important scholarship from the mathematics teacher education community. It is also the final monograph for which I served as series editor.

Moreover, during the fifteenth annual meeting of AMTE, we launched our 20th Anniversary Celebration. The new anniversary logo was introduced, which was on participants' folders and on commemorative pins that were sold for \$5.00 each to raise money for graduate student scholarships to enable more students to attend the next annual meeting. In addition, AMTE trivia questions were inserted throughout the program booklet. However, the most exciting element of the launching of the 20th Anniversary Celebration was when Susan Gay and Nadine Bezuk received recognition for their contributions to AMTE over the years. In honor of Susan Gay the *Susan Gay Conference Scholarship* will be awarded annually beginning in 2012 to support a graduate student or early-career MTE to attend the AMTE Conference. Also, the AMTE Excellence in Service Award was presented to *Nadine Bezuk* and was renamed to become the *Nadine Bezuk Excellence in Leadership and Service Award*. We hope that you will join us as we celebrate our 20th Anniversary throughout the coming year. Culminating events will occur during the 2012 annual meeting.

maintain the Elementary Mathematics Specialist initiative. Margaret (Peg) Smith of the University of Pittsburgh, the first editor of the new journal, *The Mathematics Teacher Educator (MTE)*, co-published by AMTE and NCTM, and the Editorial Panel, comprised of representatives from AMTE and NCTM, have already begun to organize and plan for the journal. Furthermore, we will extend the work surrounding ways that we can more effectively advocate on behalf of mathematics teacher educators in discussions related to teacher education policy.

In addition to continuing the work of the previous year, the Board of Directors established some new action priorities for 2011 during the annual meeting.

- **Develop a stronger communication plan.** The AMTE Board of Directors proposes that we increase the opportunities for members to communicate and collaborate within and outside of the conference. We plan to do this through current and new methods including: sending important messages to members via email courtesy of our executive director, Nadine Bezuk; utilizing the AMTE website to post articles, reports and editorials relevant to our members; making the AMTE Connections Newsletter more interactive; and hosting blogs centered around teaching and teacher education. We welcome other ideas from members.
- **Provide guidance and resources for MTEs related to implementation of CCSS.** As stated by Barbara Reys, past AMTE president, in the Winter 2010 *Connections Newsletter*, AMTE has been involved with several initiatives related to the Common Core State Standards. We will continue this work by providing members with information related to the CCSS, developing tool-kits for MTE's to help with implementation, and participating in collaborative meetings aimed at supporting the implementation of the CCSS with the National Council of Teachers of Mathematics (NCTM), the National Council of Supervisors of Mathematics (NCSM), the Association of State Supervisors of Mathematics (ASSM), and other organizations.
- **Establish an AMTE Foundation.** This Foundation, similar to the NCTM MET fund, will solicit private contributions for specific purposes (e.g., scholarships for conference travel, MTE early career work, or other worthy causes supporting the profession). Moreover, the AMTE Foundation will provide additional resources to fund particular new initiatives and support the goal of financial stability for AMTE.

As we move forward into 2011, celebrating our past, participating in the present, and preparing for the future, I hope that you will be actively involved in the organization's endeavors. For information about the 16th Annual Conference of AMTE to be held February 9-11, 2012 in Fort Worth, TX see additional information elsewhere in this Newsletter. In addition to contributing as a speaker or attending the annual conference of AMTE, there are many other ways to serve. This category was recommended to the AMTE Board by the AMTE Membership Committee in response to suggestions brought forth from current members. The category of Emeritus Member will be open to all retired individuals who are interested in the goals of AMTE. Emeritus Members will have all the rights and privileges of regular members, and Emeritus Member dues will be 50% of regular members' dues.

The next step for approving this amendment to the AMTE Constitution is for the membership to vote on it. An online vote will be conducted via the AMTE website. AMTE 2011 15th ANNUAL CONFERENCE REVIEW

AMTE 2011 Conference Attendance a Record 579!

On January 27-29, 2011, AMTE hosted our Fifteenth AMTE Conference in Irvine, California. A record 579 people registered for the conference. There were many outstanding speakers and numerous opportunities for those attending to meet and share ideas with each other. Food was served often and the meals provided time to meet new colleagues and do committee work. New this year, graduate students attending the conference had an opportunity to meet each other and AMTE leaders at a Thursday evening reception.

During the conference, representatives of six organizations joined us and brought materials and information of interest to members. We are pleased to recognize the support of Pearson Education, W. H. Freeman & Company, John Wiley & Sons, Inc. – Higher Education, the National Council of Teachers of Mathematics (NCTM) Mathematics Education Trust, National Council of Supervisors of Mathematics (NCSM), and the Brigham Young University (BYU) Mathematics Department's WeUseMath.org website.

Nine preconference sessions, addressing a variety of topics, were held on Thursday morning. Beginning at 1:00 p.m. on Thursday and ending Saturday morning, 146 sessions were held. We welcomed Marilyn Burns as the speaker at the Opening Session and William F. Tate as the speaker at the Closing Session. As usual, the Judith E. Jacobs Lecture was a highlight of the conference; this year's lecture by Joan Ferrini-Mundy, Michigan State University, was titled *Learning for Tomorrow: Challenges and Opportunities in Mathematics Teacher Education*.

At the business meeting on Saturday, members were encouraged to make plans to attend the Sixteenth AMTE Conference, which will be held at the Fort Worth Renaissance Worthington Hotel in Fort Worth, TX on February 9-11, 2012. 2011 AMTE AWARDS

At the 2011 AMTE conference in Irvine, California two individuals were recognized for their work and contributions to mathematics teacher education.

Dr. Rochelle Gutiérrez of the University of Illinois at Urbana-Champaign received the **2011 AMTE Excellence in Scholarship in Mathematics Teacher Education Award**. This award recognizes a colleague for a significant contribution to the field of mathematics teacher education through his or her scholarly publications and activities. As a recipient of the award Rochelle presented a talk at the conference entitled "Playing/Changing the Game: Rethinking the Knowledge that Mathematics Teachers Need to Teach Marginalized Students".

Rochelle's research and publications have made significant contributions to mathematics education as it relates to equity, sociopolitics, and, more recently, ethnomathematics. By situating teacher practice in a socio-cultural and political context of schooling, Dr. Gutiérrez's work has highlighted important areas in mathematics teacher education, and she has made both theoretical and applied contributions to research in the field of mathematics teacher education. She believes that students can be empowered in mathematics classrooms to become active participants in their learning and critically analyze the world to be able to contribute to the betterment of society through mathematics.

Dr. Kathryn Chval of the University of Missouri received the **2011 AMTE Early Career Award**. The Early Career Award is given annually to recognize a colleague's contributions in his or her program of teaching, service, and/or scholarship within the first decade after receiving a doctoral degree. Kathryn was recognized for her many publications and presentations as well as her incredible record of funded grant projects. Her research looks at participant knowledge as well as effective models, strategies, and support structures that facilitate the development of that knowledge across the teacher professional continuum. She has served as PI or co-PI on funded projects exceeding 17 million dollars. She collaborated with a science educator to establish the Missouri Center for Mathematics and Science Teacher Education which was funded by the U.S. Department of Education.

Kathryn is an exemplary teacher. She has received the college teaching award six times. Her students rave about her as an instructor who has high expectations while showing how much she cares. As recipient of this award, Kathryn will present a session at the 2012 AMTE conference highlighting her work.

Announcing the 2011 National Technology Leadership Initiative Fellowship Award Winner

The Technology in Mathematics Teacher Education Committee is pleased to announce the 2011 National Technology Leadership Initiative Fellowship Award winners: **Melfried and Judith Olson from the University of Hawaii and Michael Gilbert from the University of Massachusetts, Boston**. They will present their paper at this year's Society for Information Technology and Teacher Education (SITE) Conference in Nashville in March, <http://site.aace.org/conf/>. Drs. Olson and Gilbert presented work conducted by a team of ten researchers from the University of Hawaii that compared two different professional development models for implementing formative assessment on student achievement of algebraic concepts in networked classrooms. One model implemented formative assessment and TI-Navigator technology simultaneously and one model implemented formative assessment and TI-Navigator sequentially. The study focused on 30 seventh-grade mathematics teachers from 15 schools.

In their presentation, *The Nexus between Formative Assessment and Technology in Networked Classrooms. What Have We Learned?*, they discussed what they learned related to growth in student achievement, teachers' practices and perceptions, teachers' assessment knowledge and self-efficacy, teachers' perceptions of using technology, teachers' effective implementation of formative assessment and TI-Navigator, and teachers' content knowledge for teaching. Among the findings of interest to AMTE membership are content knowledge for teaching was a significant predictor of student achievement, in the year teachers began using the TI-Navigator System their content knowledge for teaching increased significantly, and self-efficacy in using formative assessment was a significant predictor of student achievement.

The National Technology Leadership Initiative (NTLI) fellowships were established to recognize exemplary presentations related to integration of technology in the core content areas at the annual meetings of each participating association.

Next year, the NTLI award will be given to an exemplary paper rather than a presentation. Unlike previous years, a paper will be submitted before the AMTE annual meeting. The award winner(s) will present the paper in a highlighted session at the AMTE 2012 Annual Conference in Fort Worth, Texas.

AMTE Elementary Mathematics Specialist (EMS) Initiative Update

In 2009, the AMTE Board of Directors identified the preparation of elementary teachers of mathematics as a strategic priority of the organization and directed a Project Team to address the issue. With support from The Brookhill Foundation, Phases I and II of the EMS Initiative have been completed.

During Phase I, the AMTE EMS Project Team identified knowledge, skills and dispositions essential for teachers who specialize in teaching and learning mathematics at the elementary level. The resulting document, *Standards for Elementary Mathematics Specialists: A Reference for Teacher Credentialing and Degree Programs* (2010), builds on prior work done by the Conference Board of Mathematical Sciences (CBMS), the American Statistical Association (ASA) and the National Council of Teachers of Mathematics (NCTM) on behalf of NCATE. The standards are intended to provide guidance to state agencies that choose to initiate state-level EMS certification and to institutions developing programs to prepare and support EMS professionals. Copies of the standards were distributed to all AMTE members, members of the Conference Board of Mathematical Sciences, and NCTM Board members. An executive summary of the standards was given to attendees of the 2010 NCSM conference. The standards document is available to the public at the [AMTE website](#).

During Phase II, a position statement on EMS was jointly developed by representatives of AMTE, ASSM, NCSM, and NCTM. *The Role of Elementary Mathematics Specialists in the Teaching and Learning of Mathematics* is available at each organization's website (www.amte.net). Also during Phase II, a national conference of twelve state teams was held in Louisville, Kentucky. The purpose of the conference was to share the AMTE EMS Standards, as well as EMS certification processes and programs from several states. The expected outcome of the conference was to spur these states to begin the process of establishing state-level EMS certification. Recently, Kentucky, Maryland, and Missouri have had EMS certifications approved and California has revised its certification.

Based on the success and momentum of Phases I and II of the EMS Initiative, AMTE will engage in a third phase of work funded by The Brookhill Foundation. We are excited to announce a second EMS State Certification Conference in Louisville, KY on July 7-9, 2011. Applications, available on the AMTE website, are being accepted until April 29, 2011.

California Association of Mathematics Teacher Educators (CAMTE)

The CA affiliate, CAMTE, had two full days of sessions at the annual meetings of the California Mathematics Council in Palm Springs and Pacific Grove, CA, in fall 2010. Two important sessions discussed the new guidelines for elementary math specialist credentials in CA, a two-level credential called the Mathematics Instructional Added Authorization (MIAA) and Mathematics Instructional Leadership Specialist Credential (MIL); the sessions gathered ideas about how CAMTE can help campuses around the state develop new programs to meet these new guidelines. CAMTE has formed an Advocacy Committee this year, one of whose goals will be to form a subcommittee on the math specialist credential. We envision this subcommittee developing a template to meet the new state guidelines that other members can use to facilitate development of their own programs. Goals for this year include: making our advocacy with state entities more proactive; increasing membership and membership services; and communicating with members more regularly via an e-newsletter.
