## **Open Rank Professor in Mathematics Education – College of Arts, Sciences & Education**

### **Job Summary**

The Department of Teaching and Learning in the College of Arts, Sciences & Education at Florida International University (FIU) invites applications for a full-time (9 month) Open-Rank Professor in Mathematics Education. FIU is a Carnegie R1 Research University and Hispanic Serving Institution with over 54,000 students. FIU has a close relationship with Miami-Dade County Public Schools (M-DCPS), the fourth largest school district in the nation, providing the largest number of new teachers to the district with 35% of M-DCPS teachers possessing an FIU degree. Thus, candidates must demonstrate strong ability in developing future teachers of mathematics, as well as working with in-service mathematics teachers.

Successful candidates will be expected to, 1) establish/maintain a strong research program (i.e., external funding, peer-reviewed scholarly work, national/international collaborations, mentoring of undergraduate/graduate researchers), 2) teach/adapt/develop mathematics education courses, and 3) provide service to the department/college in order to contribute to the Department mission in these domains.

### **Minimum Qualifications:**

- Earned doctorate in Mathematics Education, or related field with appropriate background in mathematics and/or mathematics education.

### **Desired Qualifications:**

- Demonstrated excellence or potential for excellence in research is expected, and grant procurement commensurate with experience is recommended.
- Demonstrated commitment to equity in mathematics education as evidenced by past or current research, teaching, and service activities.
- Evidence of chairing, advising, and mentoring graduate students commensurate with experience is expected.

- Minimum of 3 years teaching mathematics in K-12 settings is highly preferred, along with expertise in teaching mathematics in culturally and linguistically diverse settings.
- Evidence of commitment to work with public schools, other community agencies, as well as other units in the university is valued.
- Demonstrated record of leadership at state, regional, and national levels commensurate with experience.

### **Responsibilities:**

- Work closely with mathematics education faculty in the Department of Teaching and Learning.
- Teach undergraduate and graduate mathematics education and STEM education courses for elementary, secondary, and tertiary level teachers.
- Supervise clinical experiences, and mentor graduate students completing research projects, theses and/or dissertations.
- Support the College, Department, and University commitment to deliver a quality mathematics education program to preservice and inservice teachers and professionals within a culturally and linguistically diverse community.
- Develop and sustain a research agenda relevant to mathematics education and collaborate on the pursuit of external funding to support scholarly activity.
- Engage in service to the Department, College, and University, as well within the broader education community.
