In addition to teaching, scholarship and Faculty/University service activities, the successful candidate will be expected to develop and sustain strong collaborative relationships at the local, national and international level, with educational organizations and other professional partners.

Preference will be given to candidates who:

- have experience teaching mathematics in K-12 school settings;
- can demonstrate that their research and teaching foregrounds one or more of the following areas:
 Equity and Mathematics Education, Indigenous perspectives and Mathematics Education, Technology in Mathematics Education: and
- can demonstrate their use of theoretical perspectives that are aligned with and will advance the Mathematics Education program of the Faculty of Education.

The Department of Curriculum, Teaching & Learning in the Faculty of Education currently has 23 full time equivalent (FTE) faculty members engaged in research, service, and teaching in the Bachelor of Education (BEd), Post-Baccalaureate Diploma in Education (PBDE), Master of Education (MEd) and Doctor of Philosophy (PhD) programs. The Department offers courses in the following graduate specialization areas: Language & Literacies Education; Second Language Education; and Studies in Curriculum, Teaching & Learning Education.
